How to operate a drilling rig safely?

work with their certificates. z Rig operators must comply with safe operation regulations of the drilling rig. operation manual. operation manual. after failures eliminated. z Ensure to release all high pressure pipes or hoses completely before disconnecting them. Ensure to cut off the power supply before repair electric circuits and equipments.

What are the duties of a drill rig supervisor?

The Supervisor shall ensure that the rig is positioned exactly over the pegged site and away from any potential hazards such as overhead electrical cables. Monitoring drilling depth,penetration rate,and drill cutting samples is part of the Supervisor's duties.

Who is responsible for re-drilling a borehole?

If the need for re-drilling arises due to the Drilling Contractor's actions,the Drilling Contractor is to be instructed to re-drill the borehole at his own cost. However,if the responsibility lies with the Supervisor,he/she is to undertake corrective measures if possible.

Can the community handle drilling supervision?

The community can support drilling supervision by tracking the drilling process and recording select information. However,they cannot be responsible for technical or contractual details. If the community is to support drilling supervision,at least two literate individuals should be appointed as Drilling Monitors.

What is Module 3 of the borehole siting and drilling supervision consultancy?

Module 3: Borehole Siting and Drilling Supervision Consultancy. The Consultant's role includes inspecting and examining the Site,its surroundings,data on geological,hydrogeological and hydrological conditions,and other environmental aspects.

What does a drilling supervisor do?

Once the site has been located correctly,the drilling supervisor approves the set-up of the drilling rig and drilling. Prior to mobilisation,a meeting between the Concern Worldwide,Contractor and drilling Supervisor is essential. At the meeting,all three parties go over the design,materials and procedures for each step in the contract.

A Rig Manager (also known as OIM - Offshore Installation Manager for offshore rigs) is the highest-ranking supervisor on a drilling rig. They are responsible for overseeing all ...
